### Curbside Pick Up Only

January 2021



If the District is in a district or building hybrid model, or In-person Learning model, meal pick up times will be Monday or Thursday from 11:30 a.m. - 1:00 p.m.

This means if a building is in a hybrid model or In-person learning model, meals can be picked up curbside at either the High School or Hartley on Monday or Thursday every week unless there is no school scheduled.

If the district is in a distance learning model, meal pick up times will be daily from 11:00 a.m. – 1:00 p.m. This means if the building your student attends is in a distance learning model, meals can be picked up at that building Monday through Friday every day unless there is no school scheduled.

Questions that will be asked curbside.  
What School does your student attend?  
What days do they attend School? (Group A or B/Blue or Gold)  
Are any of the children Full Time Distance Learners?

All students that eat in the building or curbside may have breakfast and lunch Free.

\*Any extra entrees or individual milk sales will still be charged to student's accounts. (Not available at curbside)

All children ages 1 – 18 can come to one of these locations and have a nutritious meal at no cost!
